1. In accordance with the Set Penalty Guide, an Umpire can offer a Reported Player a Set Penalty, inclusive of a Reprimand. Should an Umpire's report be received by the League without this sheet attached, it will be deemed that no Set Penalty was offered and the Penalty will be determined by the League.
2. When a red card is issued, this sheet must be completed at the conclusion of the match and included in the match day paperwork that is sent to the League. The reporting Umpire/s must ensure a copy of the Set Penalty Sheet is provided to each Team Manager, as well as retaining a copy for themselves.
3. Upon receiving the Set Penalty paperwork, a league at its discretion may choose to override the penalty offered should it be deemed to not be in line with the guidelines for penalties.
4. Should more than one Umpire report a player for a single incident, only one Set Penalty Sheet needs to be submitted.
5. The Reported Player or Club involved in the incident, have the right to decline the Set Penalty offered by the Umpire/s and refer the matter to the League.
6. If the Reported Player or Club involved in the incident does not sign this Sheet the League will then assess the Set Penalty and advise the Club of the charges by Monday 12pm after the game.
7. The Reported Player or Club involved has until Tuesday 9am to accept an early guilty plea. A no response will be taken as acceptance of the Set Penalty. If they don't accept, the matter will then be escalated to tribunal.
8. If the reported Player or Club does not accept the Set Penalty handed down by the League and elects to have it heard by the Tribunal, there is a strong likelihood if the charge is sustained that the tribunal will impose a sanction that exceeds the Set Penalty offered. Any early guilty plea will no longer be available as an option.
