Cancellation and Refund Policy

Please note that any catering cancelled past the catering deadline will not be refundable for any of the food purchased, and all costs will still apply. Any catering cancelled after the close of business Friday (5pm) on the weekend of an event will also be charged for the steward fee. For all weekday events, any cancellations made within 24 hours of the event the steward cost will still apply.

In the event that the gates do not open a full refund of charges will be provided. Once gates have opened, all pre-orders will be charged.

Billing procedures

Payment can be made by credit card. All of our prices are in Australian dollars (AUD) and inclusive of GST (Goods and Services Tax) as of 2nd February 2015.

At the completion of your booking, you will be required to prepay for your steward and food charges, after which a service order confirmation will be emailed to you.

At the completion of the event, your host is required to authorise all alcohol on consumption charges. These items will be deducted using the credit card details supplied within five business days. A final invoice/receipt will be emailed to you. If the host is NOT authorised to order further catering, they may provide a credit card at the event which will be charged within five business days.

If there are any queries regarding the contents of your tax invoice, please contact the Delaware North hospitality catering team within seven (7) days of receipt of your invoice.

Credit card payments attract the following charges and this will be added to your total payment amount as determined on your invoice.

- 1% for Visa/Mastercard/AMEX payments

Prices may vary from original quotations in cases where cost increases are incurred subsequent to the quotation being made. Upon any such variations becoming known, details of the same will be supplied to you. Delaware North Companies are PCI compliant, meaning we cannot hold any credit card details without prior written permission from clients. If you would like us to hold details please contact the hospitality catering team, otherwise all credit card details will be destroyed after payment has been processed.
