### Terms and Conditions

This document contains the Terms and Conditions under which the West Australian Football Commission (ABN 51 167 923 136) (Promoter) will offer rewards under its Junior Football Early Registration Promotion. (**Competition**).

The Program commences at 9:00am (WST) on Sunday 1 September 2019 and concludes at 5:00pm (WST) on Friday 1 November 2019 (**Competition Period**).

You can register any person or persons who are participating in the 2019 WA Junior Football Program, including Auskick.

You can only register via the Competition Registration System. Parents/Guardians can access this via their club or <https://play.afl/>

A **prize** winner can only be a Junior Football Club, including Auskick Centre's.

A **giveaway** winner can only be a re-registered Auskick or Junior Football participant.

The parent/guardian must successfully complete the re-registration process between the competition period listed above to qualify their local club for a prize and be eligible for one of the giveaways.

The Top five (5) best performing clubs during the competition period will receive one (1) of the prizes listed below with the first four-hundred (400) re-registered participants only to receive a giveaway listed below.

### Prize

In this program, commencing at 9:00am (WST) on Sunday 1 September 2019 and concluding at 5:00pm (WST) on Friday 1 November 2019, the winners of the prizes and giveaways will be announced on Monday 4 November 2019 by 5:00pm (WST).

- a) Prize winners deemed as 'Top 5' best performing clubs are those who have the highest percentage of re-registered participants for the 2020 WA Junior Football season during the competition period.
- b) The 'Top 5' is calculated based on the percentage of club re-registrations segmented by each club. So that if a club has a smaller member base they will not be at a disadvantage. The five (5) clubs with the highest percentage of re-registered participants from the previous season at the end of the promotion period is deemed in the 'Top 5' and qualifies for a prize.
- c) Giveaways will go to the first four-hundred (400) participants to successfully re-register for the 2020 WA Junior Football season.

- d) This will be based on the time-stamped data from the Competition Management System.

The Winners will be notified through email or phone documented in the re-registration process by a West Australian Football Commission official employee.

Winners of the prizes must supply the WA Football Commission with a valid postal address, email address, phone number and photo once told of their prize.

If a successful prize or giveaway winner does not respond to the notification within 48-hours of the WA Football Commission notifying them that they are a winner, they will no longer be entitled to the prize or giveaway and the prize will be re-awarded to the next participant or club selected.
