

WAFC PERTH ROYAL SHOW COMPETITION Terms & Conditions

1. Instructions, prizes and information on how to enter form part of these conditions of entry. By registering, entrants accept these conditions of entry.
2. The Promoter is the West Australian Football Commission, ABN is 51 167 923 136, address is Gate 6, Patersons Stadium, Subiaco Road, SUBIACO WA 6008.
3. The total promotional period begins at 9am Saturday 26 September 2015 and concludes at 5pm on Saturday 3rd October 2015.
4. Entries are open to all residents of Western Australia who are either over the age of 18 or have permission by a parent or guardian, excluding employees of the West Australian Football Commission. Entry is only available at the WAFC activation at the 2015 Perth Royal Show as part of the Yellow Brick Road program.
5. The major prize is a signed Nat Fyfe Jumper. This prize is not transferable or exchangeable.
6. If the winner of the major prize is under the age of 18 years, the prize will be awarded to the winner's nominated parent or guardian.
