RECOMMENDATION:	That the amendments to the Constitution of the League which have been recommended by the Board, as set out in the Notice, are approved. These amendments shall be incorporated into the Constitution effective from the date of this meeting.		

At the Board's October 2023 Board meeting a range of constitutional amendments were proposed which had been considered and recommended by the League's Governance, Finance and Risk Committee. There are four fundamental amendments which are being recommended. These are summarised as follows:

- 1. *Rule 5 (Membership)* updated to provide for our increasingly diverse competitions and modern governance processes.
- 2. *Rule 10 (Board)* to formalise election/voting process and how the President is appointed.
- 3. *Rule 10.13 (Nomination Committee)* to be formally adopted through the Constitution, consistent with modern governance principles and Australian Sport's Commission's best practice standard; and
- 4. **Rule 19 (Virtual Meetings)** being a new rule which has been adopted across many industries post-COVID to facilitate remote meetings.

There are other amendments which relate to formatting and clause numbering changes.
