AGENDA ITEM: Board Report AGENDA NO: 3.1

Season 2020 was one of the most challenging in our history, with a world-wide pandemic requiring governments to close borders and restrict movement of the community.

In March, as clubs were in the final stages of pre-season training and preparing for round one, the Perth Football League postponed the season after advice from the AFL and WA Football Commission.

For some time it did not look like any matches would be played in 2020. However, with easing of government restrictions, the League did complete a nine round season with a shortened finals series from July 2020. I acknowledge the incredible spirit of our club committees during periods of uncertainty that 2020 brought. Their tireless work and initiative to keep players engaged through lockdown and to retain local sponsors highlights the unique love for our game that truly defines our League.

Our end of year financial result will show the League invested hundreds of thousands of dollars from our "rainy day" reserves to support this season. That we were able to make such a decision in order to reduce the financial burden on clubs as much as possible to ensure this season went ahead, was only possible thanks to decades of effective and responsible financial management by our current and previous administrators, at League and club level alike.

We did this not just because we it was crucial to clubs from a long-term player and volunteer retention perspective but also because we know how important football is and the role it plays when it comes to people's physical and mental health.

The League also supported clubs through this period with cashflow assistance and the introduction of the Club Small Grant Program, to assist club volunteers and encourage committees to invest in their clubs. Grants totalling \$51,000 were approved for items such as ice machines for player recovery, computers for club administrators, EFTPOS systems for team managers and bar/canteen managers, and digital scoreboards. In addition, we continue to underwrite clubs using Xero accounting software to support Club Treasurers.

During 2020, the League continued to advocate for improved and new facilities with representation on the WAFC Facility Planning Committee and input into the WAFC Strategic Facilities Plan 2020-2030. Match day lighting and female friendly changerooms are a priority.


In terms of broader advocacy, the League presented at the WA Government's Public Accounts Committee review into the use of WAFC funds. Our submission, and indeed our longstanding position to the WAFC, is for an overhaul of the Commission's governance to better reflect community football. In 2021, the League will continue to promote this significant, and long overdue reform.

Our League would not be possible without the support of local government. They provide the facilities and grounds to play. In return, we engage local communities by providing for physical and mental well-being. On behalf on the Board and staff, our 69 member clubs, the hundreds of volunteers who power them and the 12,000 male and female players who enjoy playing in our league, I thank the 24 local councils who supported clubs through provision of reduced or waived ground usage fees in 2020.

I also thank our sponsors for sticking with us as they themselves were challenged by COVID-19. We do have terrific support from the West Australian Football Commission, Carlton and United Breweries, Midway Ford, Life Without Barriers, West Coast Eagles, Burley, Blackchrome, Australian Physiotherapy Equipment and Skill Hire.

I thank my fellow Board members, and our General Manager and staff for their commitment and energy over a very trying season.


Sam Birmingham President Due to the impact of COVID-19 and a reduced season in 2020, the Financial Report ending 31st October 2021 shows the League reported a \$311,850 operating loss. Though the loss is substantial, the investment was due to years of prudent financial management from the League. The League remains in a strong financial position.



In planning for a shortened season, the Board had forecast a \$400,000 operating loss but gained the benefits of the Federal Government's JobKeeper program which was passed on by the WAFC who employ Perth Football League staff.

Revenue

Affiliation fees were charged at \$500 per team. This reduction enabled clubs to field teams with the League essentially underwriting player insurances (\$225K) and ground hire (\$74K).




Several other charges were removed to reduce from affiliation fees:

- New footballs were not distributed and not charged to club through affiliation fees. These footballs, which
 were manufactured and purchased by the League, were sold to clubs or remained as inventory and will be
 used for future club purchases.
- Umpiring coaching was not levied and thus was not forwarded to the WAFC.
- Medal Presentation Dinner was not conducted at Crown and was not charged to club through affiliation fees.

Local councils were supportive in waiving or reducing (pro rata) ground hire charges. Many clubs dealt directly with their local council to achieve this benefit. Going forward, ground hire levies remaining within affiliation fees needs addressing.

Clubs were also provided cashflow relief with the League delaying repayment of club playing apparel.

WAFC grant contribution towards staffing was again reduced this financial year. Though the reduction for the 2019/20 financial year can be contributed to COVID-19, the reduction of the WAFC grant has been a trend since 2014. The Perth Football League has raised this issue and will continue to advocate for



Club investment

- For the third year, clubs introducing womens teams received complimentary playing jumpers, totalling \$8000.
- Support for Club Treasurers continued for a second year, with the provision of Xero. Tens clubs signed up to
 use Xero in 2019/20. To date, 28 clubs are now using Xero, whereby the League will pay for club set-up, 12
 months training and ongoing annual subscription, totalling \$40,000 for 2020/21.
- A Club Small Grant program was launched with \$51,000 approved. Popular initiatives included digital scoreboards and POS systems.
- A weekly podcast was launched with a 4482 listeners.
- As part of the Life Without Barriers support of Integrated Football, all teams received new playing jumpers at a cost of \$7500.
