MEN'S FOOTBALL

2020 will go down in history as one of the most challenging due to the COVID -19 pandemic that spread throughout the world, resulting in wide-spread loss of life, placing significant stress on health systems and global economic markets. Australia's Federal and State Governments were forced to close down borders and enforce strict social distancing and lock-down measures to try and combat the spread of the virus.

For the WAFL competition it meant the closure of football. At the time it was heartbreaking for the players, coaches and staff as they had just completed another grueling pre-season campaign and were ready to commence their 2020 quest when the cancellation was announced in March. Across the State, many Western Australian's spent at least 6 weeks in home isolation, which proved a successful strategy in the fight against the virus. This period, coupled with several other government measures allowed most Western Australian's to resume work and slowly get back to normality as we entered into June and July. During the shutdown our coaches and players found ways to stay connected through technology and in line with the government restrictions were able to maintain their fitness by training in small groups.

The situation continued to improve for Western Australia and football and the WAFL community found a way to get back and running with Round 1 commencing on 18 July 2020. It would be a shortened season of just eight games. The West Coast Eagles withdrew from the WAFL after just entering the competition in 2019 leaving the other nine teams to battle it out for the Premiership. The margin for error would be small as each team would play each other just once with the top four playing finals.

The players this season also need to be praised for their collective efforts in getting the competition underway. Our senior players agreed to play for 50% of their match payments as funding cuts impacted the competition due to the COVID-19.

News in Victoria and New South Wales wasn't so good with the virus spreading through the community resulting in State League Football not being played in those two States in 2020. This situation presented an opportunity for the Club to welcome home Luke Meadows who was signed to play with Williamstown Football Club (VFL), Matthew Lloyd from the Geelong Football Club (VFL) and Tristan Hobley from Sydney University Football Club (NEAFL). It was satisfying that all three of these young men played league football during the course of the season. Other players that were added to the list included Sasha Kernutt (Mines Rovers FC) and Jordan Moore (Cervantes FC) whilst Zak Patterson, Ryan Hudson, Koopah Todd, Tom Menaglio, Henry Ryan, Tyron Hindmarsh, Craig Farmer and Ewan Brazier graduated to the senior list from our 2019 Colts program.

Geoff Valentine was able to add former player and three-time Breckler Medallist Dion Fleay to the Coaching team (Assistant Coach – Backs). Dion spent the past seven years in Kalgoorlie with his professional career and successfully coached the Mines Rovers FC during his time in Kalgoorlie. Dion was a great addition bringing a wealth of experience and knowledge that resulted in our defence becoming one of the best in the competition.



Dion along with Jason Salecic (Assistant Coach – Forwards), Matt Guadagnin (Assistant Coach - Midfield), Ron Skender (Specialist Ruck Coach), Corey Green (S&C Coach), Blake Arnold (Head of Development), Brent LeCras (Development Coach) and Todd Stewart (Development Coach) all did outstanding jobs given the challenges the season bought along and under Geoff's leadership they are absolutely committed to getting the best out of the player group and will continue to strive to winning the next premiership for our Club.

Season 2020, although short produced many highlights and some outstanding football resulting in the league team finishing third on the ladder with six wins and two losses at the end of the regular season and making a Preliminary Final. We were bitterly disappointed to not win this game losing to eventual Premiers, South Fremantle by 21 points but no doubt this will drive the Club to bigger and better achievements next season and beyond.

This aside all of our members can once again be proud of the efforts of their team. Throughout the season the performance was consistent, and the West Perth spirit displayed by the team was strong. We won the Polly Farmer Shield against our old arch-rivals East Perth for the fourth year in a row, we beat the reigning premiers Subiaco for the first time since 2016 ending their finals aspirations, had a comprehensive victory against Peel Thunder in Round 3, and maintained our unbeaten record against the Demons that stretches back to 2011, with two victories this season including a terrific 1st Semi Final win in front of a big crowd.

Seven players earned their league debut's in Season 2020. Congratulations to Tom Boyes, Zak Patterson, Matthew Lloyd, Lachie Johns, Tristan Hobley, Heath Chapman & Sasha Kernutt who all did themselves and the Club proud. I would like to make special mention to Zak Patterson who won this year's Rising Star Award after playing five senior games in his debut season and showing plenty of upside in what hopefully is a long and bright future with the Falcons.

To all the award winners this season I congratulate you on your efforts, but it is worth singling out Shane Nelson who won his 4th Breckler Medal as the Club's Fairest & Best player. In doing so Nelson moved into equal 3 rd on the all-time list of Fairest & Best winners at the Club, joining Checker O'Keefe who won 4 Fairest & Bests between 1938 – 1941. There is only two men that have won more Fairest & Best awards in the club's history and they are Ray Schofield (5) and AFL Hall of Famer, Mel Whinnen (9). Shane had an extraordinarily consistent season averaging over 26 disposals, 6 tackles per game and maintained his clearance supremacy as one of the premier midfielders in the competition.

This year the Club was pleased to strike a new medal named after one of our greats in Jason Salecic. The Jason Salecic Medal will be awarded to the Runner-up Fairest & Best player and in 2020 our inspirational skipper Aaron Black was the recipient of the award. Black also had a superb season averaging over 25 possessions and 5 tackles a game whilst leading his team to a Preliminary Final. Aaron chalked up his 200th senior game for the Club in Round 9, leading the team to a terrific win against Subiaco. This season was the 8th consecutive year Aaron has finished in the Top 3 of the Fairest & Best – an inspiring record!

This season also bought the end the football careers of Michael Lourey, Brayden Antonio, Ben King and Laine Rasmussen when they announced they would be hanging up their boots.

Michael finished his career playing 202 League Games of football across Victoria and Western Australia. Michael represented West Perth on 112 occasions after joining the Club in 2015. Michael won the Club's leading goal kicking award in his first two seasons at the Falcons and in his six years never missed finals. Prior to joining the Falcons Michael played 63 games for Frankston FC, 26 games for Sandringham FC and 1 State Game for Victoria. An outstanding club man, Michael was always team first and very popular with all his peers over his nine seasons on the senior list.

Brayden retires after starting with the Club in 2011 in the Colts program and finishing with a tally of 163 Club games (39 League, 91 Reserves & 33 Colts). Brayden won the Reserves Fairest & Best (Ennis Medal) in 2015 and played in two WAFL Reserves Premierships (2014 & 2019).

Ben retires after 6 seasons and 68 League Games. The no-nonsense defender was recruited to the Club via the Gin Gin FC and debuted in 2014, the year he was also a member of the 2014 Reserves Premiership team. Ben also played in the 2018 League Grand Final and although the day belonged to Subiaco, Ben played with great passion for the jumper and was a key member of the club's defensive unit during his career.

Laine Rasmussen announced his retirement calling time on an outstanding career that yielded 102 senior games, a League Premiership and a list of achievements that most aspiring footballers would dream of, that included playing State Football for Western Australia and winning two Wayne Dayman Medals as the Clubs Most Courageous Player.

Brayden, Michael, Ben and Laine have made significant contributions to the Club during their careers and we wish them and their families all the very best in the next chapters of their lives

SENIORS COACH REPORT

Whilst the sands of time will erode the vividness of challenges encountered in 2020, I have no doubt that it will long be remembered for the global and local threats and opportunities it generated. In the WAFL space, there was a very real threat to the season but when that threat passed, a genuine WAFL Premiership opportunity presented itself. The Club as a whole, worked strategically and diligently to deliver that Premiership and whilst we can be proud of what we achieved, I can't help but think we missed an opportunity to deliver the Club another League Premiership.

The 2020 season included some great wins. Putting East Perth to the sword during the home & away season is always noteworthy and being the team to extinguish Subiaco's hope for another Finals series was season highlight. Unfortunately, we lost our way a little in the last quarter, enabling Subiaco to claw back some of the margin. It made no difference to the outcome of the game or to Subiaco's participation in the finals, but it did see us slip from 2nd spot and a Second Semi-Final berth into 3rd position and a First Semi-Final by the barest of margins. Those little 'half-chances' can make all the difference when chasing a Premiership and when that slip was compounded by a serious knee injury to Laine Rasmussen, it became a genuine setback to our Premiership aspirations. Thankfully, the boys responded wonderfully the following week against Perth in what was an Elimination Final. Perth was riding a wave of momentum having qualified for their first final series in 22 years and for our boys to hold their ground and then push back against the tide late in the game was a fantastic performance.

The Preliminary Final loss against South Fremantle is one that will sit with me for a long time. We had our chances in the first 40 minutes of the game but weren't able to capitalise on our ascendancy during this period. A poor opening 10 minutes of the 3rd quarter saw South Fremantle effectively take the game out of our reach. Watching them go on the win the 2020 WAFL Premiership has strengthened our resolve to be better in 2021.

Such a positive performance in the challenging season that was 2020 could not be achieved without the wonderful input of the coaches that assist me. Blake Arnold, Jason Salecic, Matt Guadagnin, Deon Fleay, Todd Stewart, Brent Lecras and Ron Skender make up what I consider to be the best WAFL Assistant Coaching Panel in the competition. COLTS COACH REPORT

The West Perth Football Club Colts programme focuses on developing our talented young footballers both on and off the field. Our programme works to develop on field skills and strategy, the leadership qualities of our players, resilience through feedback and accountability, and to build a culture of support and care for all members of our community.

In what was an extremely challenging year for everyone, our 2020 season proved to be a very successful year for the Colts programme, both on and off the field This is largely due to the planning and persistence, through hard work by many over the past 3 years to develop our standards and maintain consistent behaviors to a point where it translated to on field success.

ON FIELD

The Colts finished the regular season with six (6) wins and two (2) losses, finishing the regular season third (3rd) on the ladder. We played some very good football, and for the 1st time in my time at the club we were able to hit the scoreboard quickly and often. This result meant the Colts Squad qualified for our second finals series in a row. This is the first time in the clubs history that has occurred. We are finally establishing an environment where finals are expected, not a surprise.

Unfortunately, we were not able to perform at our best in the 1st semi-final against East Fremantle. They were able to play a more consistent, team focused football and were deserving winners. We will learn from the contest, and make sure that when we get back to this situation, we are all better equipped for the situation.

As a coach, this role definitely has its hard moments. One of the more pleasing aspects of our role is telling a young man he is going to make his debut for the WPFC. In the condensed program, and playing good football, we were still able to select 18 players to play their first game for the West Perth Football Club at this level.

At the conclusion of the WAFL season, the WA State Program held a two game All Star series. Over the 2 games we had eight (8) represent Team Black And Team Gold. Congratulations to Heath Chapman, Kellen Johnson, Michael Mallard, Logan Foley, Callum Johnson, Darcy Dixon, Corey Rundle and Lochy Paton. Over the 2 games, both sides ended up winning a game by 55 points.

Every year the WAFL selects a Colts Team of the year. Well done to Heath Chapman, Corey Rundle, Darcy Dixon, Michael Mallard and Callum Johnson on their selection in this team. A great reward for their efforts at Colts level in 2020. 5 players was the most from any side this year.

The relationship between the Colts program and the Senior Program is an important one at any WAFL Club. We are very lucky at West Perth to have the support of Senior Coach Geoff Valentine, General Manager of Football Operations Steve Trewhella, Reserves Coach Blake Arnold and all of the Senior playing list.

Additionally, during the season three (3) players from the Colts programme were selected to play senior football. Callum Johnson made his Reserves debut in Round 7 against East Fremantle and played 3 games. Tommy Taylor-Shreeve played against Perth n Round 5. Heath Chapman was rewarded with a League debut in Round 8 against Claremont after some outstanding form in the Colts program. Other award winners this year included Heath Chapman taking out the WAFL Colts Coaches MVP award and Corey Rundle winning the Leading Goal Kicker for the Colts Competition The AFL Draft is always an important occasion in any young footballers' development.

STAFF & SUPPORT

At West Perth, we have one of the best coaching staffs in the Colts competition. Adam Radici (Backline), Tom Moscarda (Midfield) & Jay Carroll (Forwards) worked throughout the season and did an amazing job with the players. All three will be back in 2021, which will give our program some continuity in our coaching. Development Coaches Dean Smith and Steve Hazell assisted them and provided support to the whole playing group. I ask a lot from our coaches, they are an incredibly collaborative team, and they worked hard week in week out to have our players ready to play a good quality of football.

At West Perth, we are very lucky to have quality people in all areas of our programme. Bryce Williamson runs our Strength & Conditioning program. His tireless work to implement a quality program that is individualised to each player, is the best in the business. Bryce had some great support from several interns from our Strength & Conditioning Partner The Athletic Institute. Nathan Stephens, Alex Styan and Jess Fordham have worked to create an amazing Medical team. We are very lucky to have a physiotherapist, sports trainers and other support staff a every training session and game. Their care for our players and the program is evident for everyone to see and very much appreciated. We were lucky enough to have Colin Taylor come on board as our Team Manager this year. DEVELOPMENT REPORT

2020 was a challenging (for obvious reasons) yet successful year for our West Perth FC talent programs. Another really fun, professional program that all the players and coaches got a lot out of. We began again in late November with over 150 young talented footballers and 30 eager coaches and support staff.

Ash McKeown was heading the Les Fong Futures (16's) in his second season as Head Coach, while Ryan Lasscock was taking the reins of the Colts for his 4th season. We continued our relationship with Athletic Institute our Strength & Conditioning partners who again had an impact at the WAFL Colts Combine Testing day with our Colts performing the best overall on the day. Finished 1st in the comp for Yo-Yo and 20m sprint tests. Like last year, our group continued to celebrate each other's success. We were by far the loudest, most energetic and close group, which I believe was the catalyst in keeping us resilient during the peak of the COVID-19 breakout and in-turn jumping out of the blocks when the season re-started.

An enthusiastic coaching group headed by Ash saw our Futures win just 1 of their first 3 games, but like the Colts were able to stay connected during the COVID lock-down and bounced back upon the restart winning 2 of the final 3 games. We were competitive in our 3 losses finishing 5th overall. Whilst the wins were fantastic it was great to see these young players get a real taste for what WAFL football is like. They matured physically, mentally and emotionally through the program and again were considered a tight group.

As a result, 5 players were selected in the Simply Energy WA State 16's Squad which building on last season, is the most representatives from our Club in recent years. 5 players were given opportunity to train with the Colts throughout the season, with Kane Bevan and Griff Julian making their Colts debut.

Our Colts squad too had some coaching & support staff changes and they were clearly able to get the best out of our young squad. Finishing 3rd on the ladder after the shortened home and away season, playing finals for the second consecutive year, a feat our Colts program has never achieved. Despite losing to East Fremantle in a disappointing Semi-Final, the top 3 sides were all considered to be really even and the standouts. We were able to defeat both Grand Finalists throughout the year, it's just a shame were weren't able to get through to the next stage and really showcase our ability on the biggest stage.

Our fantastic season was noticed again as 8 players were selected in the revamped Simply Energy WA State 18's Squad. Additionally, 5 players were selected in the Simply Energy WAFL Colts Team of the Year and for the second year running we were the most represented Club and this is the most West Perth FC representative in our Clubs history.Furthermore our Colts Coach Ryan Lasscock was awarded Colts Coach of the year.

We had some more significant highlights along the way with 3 players making their Senior Debut – Tommy Taylor-Shreeve, Jack Downsborough and Callum Johnson in the Reserves. Not to mention Heath Chapman who continued his strong season earning a League debut. Heath Chapman won the Combined Past Player and Officials Colts Coaches Awarded (WAFL Coaches MVP) for the first time in the Club's History. He then added to his trophy collection winning the Dominish Medal (West Perth Colts F&B) by a big margin (44 votes) over Michael Mallard (25 votes), 16-year-old Kane Bevan (22 votes) and Callum Johnson (21 votes).

There are so many great volunteers to thank for such a great season. I would like to acknowledge the hard work of everyone involved in our programs especially in such a challenging year with so much uncertainty. So many of you were able to stand in and keep the program moving forward while I was stood down in my role at the WAFC and needed to work away. You are all in it for the right reasons and I love the commitment you have to these young players and helping them succeed on and off the field. I am appreciative of the culture you help create to nurture these players talent. The Club truly is a place our volunteers wish to spend their leisure time and I thank you all for making this a place people want to come to.



Well done to Ash and his team for a well-run Futures program. There were a number of challenges along the way, but you and your team kept things running smoothly and got the most out of the players. The coaching group you have helped put together are a tight, fun unit. You will all take pride in watching these young footballers develop through the Colts program and beyond over the next few years.

Credit must be given to Ryan Lasscock! You have a remarkable ability to earn buy-in from players, coaches and support staff and its pleasing to see you get recognition outside our four walls with an opportunity to coach in the State 18s program and your coach of the year award. Colts success over the past 3 years was no fluke and for the first time in our Clubs history our Colts squad is talked about being a 'team to beat' each year. Your ability to help keep the program moving forward during the peak lockdown stage of the coronavirus pandemic was amazing, the players remained engaged and we jumper out of the blocks at the re-start winning 5 games straight. Our group continues to get closer and closer each year and there is now more and more players and coaches working at higher levels who have you to thank for helping them reach their potential. Our assistant coaches and support staff continue to do a wonderful job giving up their time to help our players and our program succeed. This simply wouldn't be the case without such a great coach at the helm.

Cohen Stickland and James Duyvestyn were two young casual employees working in the talent space who continued to support me, the coaches and the program in a range of areas. We wouldn't be able to run such a fantastic program without the experience and knowledge you provide to the Club. You take on such a wide variety of tasks without hesitation and nothing is ever too much and for that we thank you.

Since the move of Talent to the WAFC there have been a number of challenges, but our Club, through Steve Trewhella, Joe McCarthy, Paul Cox and Geoff Valentine continue to support me, Sass and the talent programs. We clearly lead the WAFC in connection between the programs which plays a big part in why we are so successful in retaining our Talent players, coaches and support staff. Because of their wholehearted support I have no doubt the move of Talent Programs back to the WAFL Clubs will be a smooth, seamless one for the West Perth Football Club. Additionally Mick Ablett (Talent Pathways Manager), Simon Moore-Crouch (Executive Manager Talent) and Scott Baker (Executive Manager WAFL) continue to offer support to our talent programs and allow me to be the best I can be.

Development Squads

Unfortunately, COVID had a massive impact on the development squads this year. The decision was ultimately made to only run programs for the 14s (2006 born) players.

60 young talented players from our zone were selected to the program that included 6 weeks of training then carnival matches vs Subiaco FC and Swan Districts FC. The Club did elect to run a small bite sized program for the 15s (2005 born) players. This was a rather unique, yet exciting 2-day program that consisted of a football training session and then an AFL style combine test at the Athletic Institute facility, culminating with an intra- squad match the following day.

Again, we were able to engage with all Junior Community Clubs and Schools to ensure we selected the very best talent in our zone. There was some outstanding talent on display across both programs and we are all excited to welcome these new young players to the West Perth FC family.

With over 20 coaching and support staff who were committed to the development and welfare of the players, each player was better equipped to make improvements to their football through training, education S&C and other important life skills. It was fantastic to see how far the players came along in just a short period of time. We would like to acknowledge Paul Downer, Steve Hazell, Steve Chapman and Ben Horgan along with their Assistants and support staff who did a fantastic job with our 14s and 15s Development Squads. The results both on and off the field were really pleasing and it was another smoothly run program given the challenges we all faced.

Unfortunately, the departure of former Futures Head Coach Luke Tedesco to South Fremantle meant the net was cast to find his successor. Ash McKeown (Former Colts assistant and Ocean Ridge AFC Head Coach) was appointed in the top job supported by Craig Wilson, Steve Hazell, Paul Downer, Daniel Rowe, Matt Davis and Damian Verazzi.

The program was revamped in 2019 to align more with the Colts program playing more games across the season, right up to July. Additionally, Clubs were also given the opportunity to play a select few 17 year-olds should they fit some certain development criteria.

Les Fong Futures (16s)

Another COVID affected program, we were able to get 3 games in before the peak of the lockdowns were enforced winning just the 1 and probably under-performing given the talent within the group. The group stayed engaged through the lock down phase via zoom meetings and were able to respond really well at the re-start winning 2 of the last 3 matches only losing in a close one to eventual Champions Subjaco.

After a slow start Ash and his team were able to get the most out of their players, they handled the COVID break really well and juggled the inclusions on Country/PSA players. Coaches were also able to shield the group from other issues that can arise from players in these age groups. Again, this program continues to show the successful closing of the gap between Community Football and WAFL Colts. The players were exposed to an elite football environment which allowed for growth and maturity.

Our theme for the year was 'resilience' and after all that has occurred in 2020 it's safe to say that was tested and our group passed with flying colors. The players represented the West Perth Football Club in a professional manner giving us confidence the Club's playing future is in a good position for years to come.

With the latest figures indicating 1 in 3 of all AFL players are female we are committed to continually improving our competitiveness and professionalism, providing best practice support for our players both on and off the field. WPFC is committed to its Female Football Program and the Female Pathway within the district making it a destination club in 2021 and into the future. 

Note 1. Significant accounting policies

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

New or amended Accounting Standards and Interpretations adopted

West Perth Football Club Inc has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted. The adoption of these Accounting Standards and Interpretations did not have any significant impact on the financial performance or position of the Club. The following Accounting Standards and Interpretations are most relevant to the Club.

AASB 16 Leases

The Club has adopted AASB 16 from 1 November 2019. The standard replaces AASB 117 'Leases' and for lessees eliminates the classifications of operating leases and finance leases, except for short-term leases and leases of low-value assets, right-of-use assets and corresponding lease liabilities are recognised in the statement of financial position. Straight-line operating lease expense recognition is replaced with a depreciation charge for the right-of-use assets (included in operating costs) and an interest expense on the recognised lease liabilities (included in finance costs). In the earlier periods of the lease, the expenses associated with the lease under AASB 16 will be higher when compared to lease expenses under AASB 117. However, EBITDA (Earnings Before Interest, Tax, Depreciation and Amortisation) results improve as the operating expense is now replaced by interest expense and depreciation in profit or loss. For classification within the statement of cash flows, the interest portion is disclosed in operating activities and the principal portion of the lease payments are separately disclosed in financing activities. For lessor accounting, the standard does not substantially change how a lessor accounts for leases

Impact of adoption

AASB 16 was adopted using the modified retrospective approach and as such the comparatives have not been restated. The impact of adoption on opening retained earnings as at 1 November 2019 was as follows:

AASB 15 Revenue from Contract with Customers and AASB 1058 Income of Not-for-Profit Entities

AASB 15 Revenue from Contracts with Customers replaces AASB 118 Revenue and AASB 111 Construction Contracts for annual reporting periods on or after 1 Novemebr 2019. Under the new model, the Club shall recognise revenue when (or as) the Club satisfies a performance obligation by transferring a promised good or service to a customer and is based upon the transfer of control rather than transfer of risks and rewards.

AASB 15 focuses on providing sufficient information to the users of financial statements about the nature, amount, timing and uncertainty of revenue and cash flows arising from the contracts with customers. Revenue is recognised by applying the following five steps:

- Identifying contracts with customers
- Identifying separate performance obligations
- Determining the transaction price of the contract
- Allocating the transaction price to each of the performance obligations
- Recognising revenue when or as each performance obligation is satisfied

Revenue is recognised either over time or at a point in time. Any distinct goods or services are separately identified and any discounts or rebates in the contract price are allocated to the separate elements.

In addition, income other than from contracts with customers are subject to AASB 1058 Income of Not-for-Profit Entities. Income recognition under AASB 1058 depends on whether such a transaction gives rise to liabilities or a contribution by owners related to an asset (such as cash or another asset) recognised by the Club.

The Club adopts the modified retrospective approach on transition to AASB 15 and AASB 1058. No comparative information is restated under this approach, and the association recognises the cumulative effect of initially applying the Standards as an adjustment to the opening balance of accumulated surplus/(deficit) at the date of initial application (1 November 2019).

Under this transition method, the Club elects to apply the standards retrospectively to non-completed contracts at the date of initial application.

There is no material impact of adopting AASB 15 and AASB 1058.

Refer to revenue recognition accounting policies adopted from 1 November 2019.

Basis of preparation

These general-purpose financial statements have been prepared in accordance with Australian Accounting Standards -Reduced Disclosure Requirements and Interpretations issued by the Australian Accounting Standards Board ('AASB'), the Associations Incorporation Act 2015 (WA), and associated regulations, as appropriate for not-for profit-oriented entities.

Historical cost convention

The financial statements have been prepared under the historical cost convention.

Revenue recognition

Until 31 October 2019, revenue was recognised and measured at the fair value of consideration received or receivable. From 1 November 2019, revenue is recognised at the transaction price when the Club transfers control of the services to their members and customers. The performance obligations are satisfied when the services have been provided to the customer.

Revenue is recognised for the major activities as follows:

Sales revenue

Events, fundraising and raffles are recognised when received or receivable.

Donations

Donations are recognised as revenue when received.

Grants

Grant revenue is recognised in profit or loss when the Club obtains control of the grant, it is probable that the economic benefits gained from the grant will flow to the Club and the amount of the grant can be measured reliably. If conditions are attached to the grant which must be satisfied before the entity is eligible to receive the contribution, the recognition of the grant as revenue will be deferred until those conditions are satisfied.

When grant revenue is received whereby the Club incurs an obligation to deliver economic value directly back to the contributor, the grant revenue is recognised in the statement of financial position as a liability until the service has been delivered to the contributor; otherwise the grant is recognised as income on receipt.

Interest

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

Recruitment Revenue and Expenditure

Transfer fees both received and paid for players are brought to account as income/expenses on an accrual basis upon obtaining a contractual agreement.

Other revenue

Other revenue is recognised when it is received or when the right to receive payment is established.

Government Subsidies

Income from government COVID-19 subsidies are recognised in profit or loss when the Club obtains control of the subsidies as the criteria for the subsidies are not sufficiently specific to apply AASB 15 and are recognised under AASB 1058.

All revenue is stated net of the amount of goods and services tax.

Leases

At inception of a contract, the Club assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. To assess whether a contract conveys the right to control the use of an identified asset, the Club assesses whether: the contract involves the use of an identified asset – this may be specified explicitly or implicitly, and should be physically distinct or represent substantially all of the capacity of a physically distinct asset.

- If the supplier has a substantive substitution right, then the asset is not identified;
- the Club has the right to obtain substantially all of the economic benefits from use of the asset throughout the period of use; and
- the Club has the right to direct the use of the asset. The Club has this right when it has the decision-making rights that are most relevant to changing how and for what purpose the asset is used.

At inception or on reassessment of a contract that contains a lease component, the Club allocates the consideration in the contract to each lease and non-lease component on the basis of relative stand-alone prices. *Measurement*

The Club recognises a right-of-use asset and a lease liability at the lease commencement date. The right-of-use asset is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, less any lease incentives received.

The right-of-use asset is subsequently depreciated from the commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term.

The lease liability is initially measured at present value of the lease payments that are not paid at the commencement date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Club's incremental borrowing rate. Generally the Club uses its incremental borrowing rate as the discount rate.

Lease payments included in the measurement of the lease liability comprise:

- fixed payments, including in-substance fixed payments
- variable lease payments that depend on an index or a rate, initially measured using the index or as at the commencement date
- amounts expected to be payable under a residual value guarantee; and the exercise price under a purchase option that the Club is reasonably certain to exercise, lease payments in an optional renewal period if the Club is reasonably certain to exercise an extension option, and penalties for early termination of the lease unless the Club is reasonably certain not to terminate early.

The lease liability is measured at amortised cost using the effective interest method. It is remeasured when there is a change in future lease payments arising from a change in an index or rate, if there is a change in the Club's estimate of the amounts expected to be payable under a residual value guarantee or if the Club changes its assessment of whether it will exercise a purchase, extension or termination option.

When the lease liability is remeasured in this way, a corresponding adjustment is made to the carrying amount of the rightof-use asset, or is recorded in profit or loss if the carrying amount of the right-of-use asset has been reduced to zero.

Short-term leases and low value assets

The Club has elected not to recognise right-of-use assets and lease liabilities for short-term leases that have a lease term of 12 months or less and leases of a low-value asset, including IT equipment. The Club recognises the lease payments associated with these leases as an expense on a straight-line basis over the lease term.

The determination of whether an arrangement is or contains a lease is based on the substance of the arrangement and requires an assessment of whether the fulfilment of the arrangement is dependent on the use of a specific asset or assets and the arrangement conveys a right to use the asset.

Income tax

West Perth Football Club Inc is exempt from paying income tax under the Income Tax Assessment At 1997.

Current and non-current classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in West Perth Football Club Inc's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the West Perth Football Club Inc's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

Trade and other receivables

Trade and other receivables are recognised at amortised cost, less any allowance for expected credit losses.

Inventories

Inventories are measured at the lower of cost and net realisable value. Inventories are accounted for at purchase cost on a first in first out basis.

Financial Instruments

Initial recognition and measurement

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions of the instrument. For financial assets, this is equivalent to the date that the Club commits itself to either purchase or sell the asset.

Financial instruments are initially measured at fair value plus transaction costs, except where the instrument is classified at 'fair value through profit or loss', in which case transaction costs are recognised as expenses in profit or loss immediately.

Classification and subsequent measurement of financial assets

Financial assets are subsequently measured at either amortised cost or fair value depending on their classification. Classification is determined based on both the business model within which such assets are held and the contractual cash flow characteristics of the financial asset, unless, an accounting mismatch is being avoided.

Financial assets at fair value through profit or loss

Financial assets not measured at amortised cost or at fair value through other comprehensive income are classified as financial assets at fair value through profit or loss. Typically, such financial assets will be either: (i) held for trading, where they are acquired for the purpose of selling in the short-term with an intention of making a profit, or a derivative; or (ii) designated as such upon initial recognition where permitted. Fair value movements are recognised in profit or loss.

Financial assets at fair value through other comprehensive income

Financial assets at fair value through other comprehensive income include equity investments which the Club intends to hold for the foreseeable future and has irrevocably elected to classify them as such upon initial recognition. Upon adoption of *AASB* 9, the Club has made such an election to recognise fair value adjustments on financial assets through other comprehensive income.

Financial assets are derecognised when the rights to receive cash flows have expired or have been transferred and the Club has transferred substantially all the risks and rewards of ownership. When there is no reasonable expectation of recovering part or all of a financial asset, its carrying value is written off.

Impairment of financial assets

The Club recognises a loss allowance for expected credit losses on financial assets which are either measured at amortised cost or fair value through other comprehensive income. The measurement of the loss allowance depends upon the Club's assessment at the end of each reporting period as to whether the financial instrument's credit risk has increased significantly since initial recognised, based on reasonable and supportable information that is available, without undue cost or effort to obtain.

Where there has not been a significant increase in exposure to credit risk since initial recognition, a 12-month expected credit loss allowance is estimate. This represents a portion of the asset's lifetime expected credit losses that is attributable to a default event that is possible within the next 12 months. Where a financial asset has become credit impaired or where it is determined that credit risk has increased significantly, the loss allowance is based on the asset's lifetime expected credit losses. The amount of expected credit loss is measured on the basis of the probability weighted present value of anticipated cash shortfalls over the life of the instrument discounted at the original effective interest rate.

For financial assets measured at fair value through other comprehensive income, the loss allowance is recognised within other comprehensive income. In all other cases, the loss allowance is recognised in profit or loss.

Classification and subsequent measurement of financial liabilities

The Club's financial liabilities include trade and other payables.

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the statement of profit or loss.

Property, plant and equipment

Plant and equipment are stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Depreciation is calculated on a straight-line basis to write off the net cost of each item of property, plant and equipment over their expected useful lives as follows:

Leasehold improvements	5-15 years
Motor vehicles	3-5 years

The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date.

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the West Perth Football Club Inc. Gains and losses between the carrying amount and the disposal proceeds are taken to profit or loss.

Impairment of non-financial assets

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

Trade and other payables

These amounts represent liabilities for goods and services provided to the West Perth Football Club Inc prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

Employee benefits

Short-term employee benefits

Liabilities for wages and salaries, including non-monetary benefits, annual leave and long service leave expected to be settled wholly within 12 months of the reporting date are measured at the amounts expected to be paid when the liabilities are settled.

Other long-term employee benefits

The liability for annual leave and long service leave not expected to be settled within 12 months of the reporting date are measured at the present value of expected future payments to be made in respect of services provided by employees up to the reporting date using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures and periods of service. Expected future payments are discounted using market yields at the reporting date on national government bonds with terms to maturity and currency that match, as closely as possible, the estimated future cash outflows.

Defined contribution superannuation expense

Contributions to defined contribution superannuation plans are expensed in the period in which they are incurred.

Fair value measurement

When an asset or liability, financial or non-financial, is measured at fair value for recognition or disclosure purposes, the fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date; and assumes that the transaction will take place either: in the principal market; or in the absence of a principal market, in the most advantageous market.

Note 1. Significant accounting policies (continued)

Fair value is measured using the assumptions that market participants would use when pricing the asset or liability, assuming they act in their economic best interests. For non-financial assets, the fair value measurement is based on its highest and best use. Valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, are used, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

Goods and Services Tax ('GST') and other similar taxes

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST receivable from, or payable to, the tax authority is included in other receivables or other payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the tax authority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

Going Concern

The financial statements have been prepared on a going concern basis which contemplates the continuity of normal business activities and the realisation of assets and the settlement of liabilities in the ordinary course of business.

At the reporting date the Club has a working capital surplus of \$202,765 and net assets of \$182,116.

New Accounting Standards and Interpretations not yet mandatory or early adopted

Australian Accounting Standards and Interpretations that have recently been issued or amended but are not yet mandatory, have not been early adopted by the Club for the annual reporting period ended 31 October 2020. The Club has not yet assessed the impact of these new or amended Accounting Standards and Interpretations.

Note 2. Critical accounting judgements, estimates and assumptions

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

Estimation of useful lives of assets

West Perth Football Club Inc determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

Impairment of non-financial assets other than goodwill and other indefinite life intangible assets

3(e) Gain from Deed of Company Arrangement

In 2018, the financial statements contained certain provisions for expenses relating to the calculation of the Deed of Company Arrangement. ("DOCA"). These conservative provisions were made to ensure that the club had accounted for all potential expenses relating to the administrators and creditor payments. In October 2019, on approval and finalisation of the DOCA with KordaMentha, it was found that that there was a provision excess of \$82,174. These excess provisions have now been recognised as a gain from the Deed of Company Arrangement.

Resources received free of charge - Venue fit out

West Perth Football Club Inc moved into their new offices at the Joondalup Arena on 2 November 2017. It was West Perth Football Club Inc's understanding that the fixtures and fittings at the offices were "gifted" to West Perth Football Club Inc as part of the project funding to redevelop HBF Arena. In September 2019, the ownership of the fixed assets was challenged by Venues West. During the 2020 financial year Venues West and the Club reached agreement over the ownership of the various assets, as a result an adjustment of \$151,531 was made to fixed assets and opening retained surpluses as this is a prior year adjustment. The assets that have been retained by Venues West relate predominantly to those which are permanently affixed to the building which is leased by the Club.
