

# 2021 Junior Football Early Registration Campaign

## Terms and Conditions

### Terms and Conditions

This document contains the Terms and Conditions under which the West Australian Football Commission (ABN 51 167 923 136) (Promoter) will offer rewards under its *2021 Junior and Youth Football Early Registration Promotion (Competition)*.

The Competition commences at 9:00am (WST) on Monday 7 September 2020 and concludes at 5:00pm on Monday 30 November 2020 (WST) (**Competition Period**).

The Competition is open to any person or persons who complete the following steps:

- a) **Register** any person or persons to the 2021 football season to a WA Junior or Youth Football Club before the end of the competition period. You can only register via the Competition Registration System – <https://play.afl/>

A **prize** winner can only be a Junior Football Club, excluding Auskick Centres.

A **giveaway** winner can only be a registered Junior or Youth Football participant.

The top three (3) best performing clubs during the competition period will receive one (1) of the prizes listed below with the first one hundred and fifty (150) registered participants only to receive a giveaway listed below.

### Prize

In this competition, commencing at 9:00am (WST) on Monday 7 September 2020 and concluding at 5:00pm on Monday 30 November 2020 (WST), the winners will be announced before 5:00pm on Friday 9 December 2020.

- a) Prize winners deemed as 'Top 3' best performing clubs are those who have the highest percentage of registered participants for the 2021 WA Junior and Youth Football season during the competition period.
- b) The 'Top 3' is calculated on the percentage of club registrations segmented by each club. So that if a club has a smaller member base they will not be at a disadvantage. The three (3) clubs with the highest percentage of registered participants from the previous season at the end of the promotion period is deemed in the 'Top 3' and qualifies for a prize.
- c) Giveaways will go to the first one hundred and fifty (150) participants to successfully register for the 2021 WA Junior and Youth Football season.
- d) The first participants registered will be based on the time-stamped data from the Competition Management System

Prizes allocated to the 'Top 3' top performing Junior Football Clubs are listed below:

- \$2,500.00 cash provided to the junior club for use on club facilities, updates and/or equipment
- \$1,000.00 Burley Sekem gift voucher
- Club visit, in the form of a training session or group talk from a Fremantle Football Club AFL listed player and West Coast Eagles AFL listed player. If due to unforeseen circumstances the AFL players cannot attend the club in person this 'visit' is to occur via a digital platform such as Zoom, Skype or Microsoft Teams. This visit will form part of the CBA agreement.

The total value of the prize pool is \$5,000.00.

Giveaways for the first one hundred and fifty (150) registered participants are listed below:

- The first fifty (50) to register for WA Junior and Youth Football will receive one (1) voucher to Rebel Sport for the sum of \$50.00
- The next one hundred (100) to register for WA Junior and Youth Football, excluding Auskick participants, will receive one (1) age-appropriate synthetic Burley Football.

The total value of the giveaway is approximately \$3,500.00.

The overall value of the prize and giveaway pool is \$8,500.00.

Prizes and Giveaways are non-transferable and cannot be redeemed in cash or something of the equivalent value.

If the product (Burley synthetic football) is deemed faulty, the WAFC will use its best endeavours to replace this product as quickly as possible.

Winners of the awards are outlined above will be announced by the WAFC 5:00pm on Friday 9 December 2020.

Prizes can be collected from the West Australian Football Commission at 105, Banksia Street, Tuart Hill, 6060 during office hours 8:00am-5:00pm unless otherwise arranged.

If for some reason any of the prizes outlined above are no longer available, the promoter reserves the right to replace this for something of the same or higher value.

### **General Terms**

The winner will be notified through email or phone in the registration process by a West Australian Football Commission official employee.

Winners of the prizes must supply the WA Football Commission with a valid postal address, email address, phone number and photo once told of their prize.

If a successful prize or giveaway winner does not respond to the notification within 48-hours of the WA Football Commission notifying them that they are a winner, they will no longer be entitled to the prize or giveaway and the prize will be re-awarded to the next participant or giveaway selected.

The prize is not transferable for cash or interchangeable for another prize.

The warranty on the goods and services obtained as a result of the Competition remains the sole responsibility of the supplier/service provider of the prize.

The Promoter reserves the right, at its sole discretion, to cancel, terminate, modify, extend or suspend the Competition at any time without notice.

The email address will not be sold to a third party.

By participating in this competition, Participants acknowledge that they may be required to sign the Terms and Conditions of the prize issuer in order to redeem the prize. Participants agree to comply with those Terms and Conditions, including but not limited to any expiry date, and release and indemnify the Promoter for any liability in relation to the prize or issuer.
