## FOOTBALL OPERATIONS MANAGER

## **KEPLER BRADLEY**

Darren Harper did a great job helping our young Reserves group register 10 wins in the home & away season and finishing 4th on the ladder despite an indifferent run of form at the start of the year.

Winning our last 3 games cemented another finals birth for the 8th consecutive year. We played East Fremantle in the first final and after a very slow start which saw East Fremantle kick 7 goals to our 1, our boys fought back in the last 3 quarters to eventually go down by 13 points meaning we were knocked out of the finals series. Joel Western was outstanding and looked a class above throughout the game while Anthony Treacy kicked 3 goals to keep us in the game. Luke Brown was moved to CHB after the first quarter and repelled a lot of East Fremantle's attacks while Ben Clarke was at his gut running best on the wing.

We have a really exciting future with a number of young players developing their games and knocking on the door of league selection. Mitchell Barron was simply outstanding in the first half of the year playing as an inside mid before a wrist fracture ended his season. Menno Inverarity and Finn Moloney showed in their first years that they have massive futures at the club. Ben Clarke continues to improve on the wing while Dylan Mulligan provided a target up forward and became a genuine goal kicker.

For the 6th year in a row our League side made the finals after winning 12 home & away games to finish 5th on the ladder (due to percentage). We won 7 of our 12 games by under 15 points proving once again that the WAFL competition is incredibly close and if you are off a couple of percent you can lose to anyone, as every side found out at certain stages throughout the year. Injuries to key players throughout the year really tested our depth and provided opportunities to players and they didn't let the club down.

We turned our attention to East Perth in the first final at Leederville oval. The game was played with very high intensity with pressure on every disposal and a real ferocity in 1 on 1 contested situations. East Perth jumped to a 2 goal lead at quarter time but for the next 3 quarters we were able to get the game on our terms, play more direct to goal and surging the ball forward to eventually win by 12 points. Oliver Eastland was outstanding in the ruck giving our midfield first use while Anthony Davis and Jack Lewsey continued their form off half back. Jye Bolton lead the way with contested possessions and using his penetrating kick to great effect while Talon Delacey and Zac Mainwaring kicked 4 goals between them.

We headed back to Leederville to face Subiaco in a do or die final. From the first bounce Subiaco were more physical and more desperate in the first quarter going into the quarter time break 3 goals up and all the momentum. To our credit for the next 2 quarters the game was being played on our terms and we kicked the next 6 out of 8 goals to put us only 6 points behind at 3 quarter time. After the break the momentum swung back into Subiaco's favour where they finished off strongly kicking 5 goals to nothing in the last. Anthony Davis' final series was outstanding and was named in the best again. Jack Maibaum was solid in defence with some big spoils while Callan England provided a handful for the opposition kicking 2 goals and Jack Lewsey contributed strongly.

A lot of positives came out of the year with a number of young players making the most of league opportunities. Zac Mainwaring and Talon Delacey became potent small forwards, Daniel Curtin showed the football world why he's so highly regarded with composure beyond his years and Sam Alvarez continued to develop his game on the wing. Anthony Davis had a stella season in the backline while experienced players Jye Bolton, Jack Lewsey and Oliver Eastland's durability and consistency really lead the way for our young group.

We've reached the end of another busy season for the Claremont talent programs and as always there's plenty to reflect on when it comes to the development of our up and comers.

#### WAFL COLTS

2023 was a special year as we claimed the club's 17th Colts Premiership. This result was a fantastic reward for a group of players who bought in and represented the club with pride and distinction. We had 51 players pull on the jumper throughout the season, and a total squad of 60, but obviously only 23 players got the opportunity to run out onto Optus Stadium on Grand Final day. The way that the playing 23 made their non-playing peers feel included (and the way that those not lucky enough to be playing supported those who were) epitomised the togetherness of the group which was so central to our success this year.

The boys started the season in exhilarating form, winning our first three games by an average margin of 64 points to quickly stake our claim as premiership contenders. The middle phase of the season saw some less attractive victories as we often struggled to produce four quarter performances, but our ability to win even when not at our best was a promising sign. A draw against Perth in Round 20 saw us miss out on top spot by percentage, despite recording our most successful home and away season in terms of winning percentage since 2013. Our finals performances were outstanding, with a gritty Qualifying Final win over East Fremantle followed by a clinical victory against Perth in the 2nd Semi Final. We took on the Demons again two weeks later in the Grand Final and while I can't say we enjoyed the last quarter too much from the coaches box as we failed to even register a score, we had done enough in the first three quarters to run out 11 point winners on a memorable day for all involved.

While premiership success always requires a team effort, we did have plenty of quality individual performers throughout the year who are recognised in full later in this report. I do want to acknowledge though the Top 3 in our Fairest & Best – Riley Disisto, Cody Angove and Ryley Valli – on their terrific seasons. Riley (Forward Pocket) and Cody (Half Forward Flank) were also named in the WAFL Colts Team of the Year alongside Joe Fonti (Wing), Kai Dehavilland (Interchange) and Jaxon Bizzaca (Interchange). Premiership Captain Daniel Curtin also deserves a mention, not only for his sensational leadership throughout the campaign, but also for a list of achievements that included National Academy Selection, WA MVP honours and All Australian selection at the U18 National Championships, and of course the way in which he seamlessly stepped up into our League side towards the end of the season. To cap it all off, Dan was selected at Pick 8 in the AFL Draft by the Adelaide Crows and will be joined at the highest level by Joe Fonti (Pick 44 – GWS Giants) and Zane Zakostelsky (Pick 51 – Brisbane Lions).

Following a challenging first season in the role, Colts Coach Ashley Clancy is to be congratulated for guiding the team to premiership glory, while I would also like to thank Ash's Assistant Coaches Ricki Smith, Chris Wallace, Ryan Pontifex and Andie Fagan, as well as Runners Ben Willett & Matt Sofoulis. Ash made the decision prior to the finals that he would be stepping down from the role at season's end. I would like to wish him all the best moving forward and am excited that we have again been able to promote from within to fill the role by virtue of Ricki Smith's appointment as our Colts Coach for 2024. We are also indebted to our amazing support staff, namely Team Manager Bern Willett (this was Bern's fifth Colts premiership as Team Manager); Property Managers Jack Denton and Trevor Naulls; Physiotherapist Ben Rushforth; Dr Lionel Lim; Head Trainer Elly Crowhurst and the entire club trainer group; Wellbeing Staff Shane Yardley, Dr Steve Allsop and Ryan Clune; and Head S&C Coach Andrew Jonson and his Assistants Mika Berman and Madi Cammarano. "Jono" is also leaving us after 4 years in his role where he has been an enormous asset to the club. His passion, dedication and ability to build quality relationships with the playing group (even despite the torture he inflicted on them during preseason sessions) will be missed.

#### WAFL FUTURES & DEVELOPMENT SQUADS

Our Futures squad endured a challenging carnival which yielded only one win, however the group invested strongly and were unlucky to lose two games by single figure margins. Congratulations to our 2023 Futures award winners: Encouragement Award – Sebastien Low, Coach's Award – Val Davies, Tiger Award – Charlie Cotter, Developing Talent Award – Benjamin Hall and Emerging Talent/MVP Award – Max Hansen-Knarhoi. Max also earned selection in the WA State 16s squad. Thank you to Futures Coach Ben Willett and his Assistant Coaches Craig Rogers, Ritchie Hore, Tom Willett, Andie Fagan and Head S&C Coach Jackson Edgar.

Our 14s & 15s Development Squad Programs were very successful this year as we reaped the benefits of a highly credentialled coaching staff and were able to return to a more holistic model of both on and off field development that had been the norm within our Development Squad Programs prior to COVID. My appreciation goes to our Development Squad Coaches Brendan Arundell, Brett Wenn, Andie Fagan, Ritchie Hore, Samuel Alvarez, Chris Tan, Joshua Ledger, Oscar Morcombe, Alex Zulberti, Ethan Cooper, Sam Marson, Daniel Curtin, Ben Willett, Chris Bandy and Development Squad S&C Coaches Mika Berman and Madi Cammarano.

#### REGIONAL DEVELOPMENT

2023 was the biggest year ever experienced by our regional academies, with both the Great Southern Storm and the Kimberley Spirit fielding teams in the WAFC Regional 15s Carnival and CBH Country Colts Championships. For the Spirit, this was their maiden appearance in the 15s and their first Colts visit since 2012, so a massive thank you to Garnduwa for their work in getting both teams down to Perth. In particular, Kimberley Spirit Program Manager, Ben De Meo, deserves an enormous congratulations for his tireless efforts in getting these trips off the ground. The results across the carnivals were generally very strong, particularly at 15s level, and paint an exciting picture of the talent being developed in our two country zones.

Our annual Colts fixture in Albany was this year played against Subiaco in Round 12 and hosted by the Royals Football Club. Thanks to Darrell Panizza and James McRae (both CFC past players) for their assistance in planning and delivering this event.

# EASTLAND LEAPS TO FAME BY KEN CASELLAS

In eight years as a Claremont footballer Ollie Eastland has leapt skywards approximately six thousand times in ruck contests which equates to him jumping over the Eiffel Tower about 18 times.

He has gained 206 hit-outs in 23 colts matches, 302 in 20 games for the reserves and 2495 in his 97 league appearances --- and he still loves his weekly challenges against a variety of ruck giants.

The 25-year-old Eastland rose to an elite level this year when he was rewarded with selection for the first time in Western Australia's State team for the match against South Australia and was named in the WAFL Team of the Year.

He also was recognised for his outstanding performance in the round three match against Subiaco when he received the Ralph Honner trophy for upholding the Anzac spirit. And the icing on the cake came when he was awarded the E. B. Cook Medal as Claremont's fairest and best league player for 2023.

Eastland polled 223 votes and was a clear winner ahead of Jye Bolton (190), Anthony Davis (118), Declan Mountford (117), Jack Lewsey (110) and Bailey Rogers (101).

He became the first ruckman to win Claremont's fairest-and-best award since Daniel Bandy was successful in 2006, thus ending the recent dominance of midfielders Jaxon Crabb, Jake Murphy, Luke Blackwell, Bailey Banfield, Kane Mitchell, Bolton and Rogers.

Eastland is only the tenth ruckman to win the award in Claremont's 98-year history, following Ray Nott (1930), Bill Sutherland (1945), Les McClements (1948 and 1950), John Hilton (1958), John McIntosh (1966 and 1969), Graham Moss (1977-78-79-80), Rhys Croxford (1995), Myles Quinn (2002 and 2004) and Bandy (2006).

Not only was Eastland a dominant performer, but he shouldered the responsibility of leading the ruck while long-term injuries kept Steven Miller and Kieran Gowdie on the sidelines for most of the season. Further to that he missed the support of Jack Buller after the big key forward signed with the Sydney Swans early in the season, as well as ruck pinch-hitter Max Minear missing several matches.

Eastland is an interesting footballer. He is a natural right-hander who kicks the ball almost exclusively with his left boot. At ruck contests he leaps off his right foot and has the rare ability of being able to tap the ball with either hand.

He left no stone unturned early this year in making sure he was able to overcome debilitating stress fractures in his back, injuries that had hampered him during the previous two years.

He began at Claremont in 2016, playing for the colts side at centre-halfforward and assisting the No. 1 ruckman Jeremy Goddard. He enjoyed an early success as a member of that side's grand final victory over East Perth at Subiaco Oval.

In his second year Eastland played 16 times for the reserves and five times for the league side. "I was developing as a forward ruck when Goddard and Eddie Simpson were bigger and above me at the time," said Eastland. "And I was the second string to Mitch Andrews in the league side.

"Ever since round four in 2018 I've been rucking. I love the competitiveness of it, and I look forward to the weekly challenge of playing against some giants, including Scott Jones, Brock Higgins, Lloyd Meek and many more. "Brock taught me many lessons early on when he had about 20 kilos on

me. That was what you needed, and it was the only way to find out what league footy is about.

"Percy Johnson taught me the craft of how to win. I wouldn't be here now if it hadn't been for him. And I learnt a lot from Brock, who was so fierce in the contest. He is not as agile as other players, but he certainly knows how to get it done. And Corey Gault from Swans learnt a lot from Percy and was



one of the best ruckmen I have played against."

While Eastland has been a commanding ruckman in the past few seasons, he has also impressed with his excellent ability on the ground, frequently using his agility to gain possession after ruck contests and gaining important clearances from stoppages.

"I played as a smaller player when I was younger and I think I developed skills while playing as a small," he said. "When I adjusted to being a tall,

arguments because I hated doing the same drill all the time.

"But it was brilliant and was what I needed. As soon as you contest the knock you follow up. There are about 70 to 80 stoppages during a match, and it's a pretty brutal game, jumping as a ruckman. I don't think I'll be playing when I'm 30 or 32. Hopefully, there will be a younger kid coming along who can take my spot, enabling me to play as a forward.

"In the ruck you don't have to get up really high, and I enjoy the body contact. I feel that I have got a lot stronger and can compete all game. I always respect my opponents and understand what they can do.

"I've been 98 kilos for the past year and a half, and the goal is to have a big summer in the gym and hopefully be about 100 to 102kg next year."

Eastland said that he received his back injury during the grand final loss to South Fremantle in 2020 and that he owed a great debt of thanks to Claremont's strength and conditioning team headed by Jake Shaw and physiotherapist Chloe Phelps.

"I can't thank them enough, and I wanted so much to be ready for our round one match this year that during the pre-season I spent six or seven weeks, sticking to a specialised diet, not drinking or going out, just focusing on getting my back right," he said.

Eastland said that he owed so much to so many people who have helped him during his career. "Beau Maister springs to mind," he said. "He was really hard on me, getting stronger in the gym and improving my marking.

"In every session he made me take 60 kicks into my hands to get them strong, and if I dropped one, we would go back to zero and start again. Tom Lee taught me the art of forward craft. Jye Bolton is one of my closest mates who has helped me and pushed me and Jack Buller hard.

"And lately all the younger boys have been pushing me, with young ruckmen Kieran Gowdie and Jack Burton pushing me at every training session."

"I have really enjoyed my time with Claremont, particularly playing with a handful of guys around my age over the past five or so years, guys like Callan England, Bailey Rogers, Lachie Martinis, Jack Lewsey, Dec Mountford, Jye Bolton and Alex Manuel.

"They have helped me in building my career," he said. "We have always been there for each other. It's so much fun playing with them and, hopefully, I will be able to play with them for another three or four years."

# MAINWARING AND DELACEY RISE TO THE OCCASION BY KEN CASELLAS

Mobile mid-sized forwards Zac Mainwaring and Talon Delacey have a lot in common. They celebrated their league debuts for Claremont in round two in 2022 with a remarkable victory over the reigning premiers Subiaco --- and this year they stood tall, particularly after the earlyseason loss of towering key forward Jack Buller.

Not only do they love kicking goals, but they place a heavy emphasis on tackling, one of the less glamorous aspects of the game.

And this year they met the challenge of becoming influential forwards following the loss of Buller (who was drafted by the Sydney Swans after round five this year) and the absence of Alex Manuel, the club's leading goalkicker in the previous two seasons, who missed seven matches through concussion and injuries.

The 22-year-old Mainwaring and the 21-year-old Delacey each kicked 30 goals this year to head the Claremont league side's goalkicking list, thus joining rovers John Parkinson and Peter Ding as the club's only joint winners of this award.

Parkinson, the 1967 Sandover medallist, and Ding shared the roving and rested in a forward pocket in 1968 when each booted an exact total of 36.29. Ding made a spectacular





debut when he scored seven goals on debut, in Claremont's round one winning match against South Fremantle.

Tyron Smallwood also stood out as a dangerous small forward this year, kicking 20 goals and applying great pressure with a tally of 39 tackles.

Delacey made 52 tackles during his 17 matches this year, while Mainwaring laid 51 tackles in his 20 appearances.

"To lose Buller so early in the season was devastating," said Mainwaring. "He was playing some great footy and was so influential and such a big presence up forward. But we couldn't dwell on his loss for too long because we had games to play, and we worked on other strategies without him. And that ended up working well."

Delacey agreed, saying: "We had to accept it and we moved on quickly. So, we had a smaller forward line and we gelled quite well.

"We are smaller, mobile players. The big boys aren't as mobile, so we've got to do a lot of the tackling, much of which is because we run so high up the ground, which is the role of our high forwards. We try to put pressure on with our tackling. I had a half-forward role, and with a lot of running was able to support the backs."

Mainwaring described himself as a high pressure forward, saying: "I aim to be creative, and I use my speed and

tackling pressure to create scoring opportunities for my teammates and for myself. I feel I'm a pretty selfless forward who does a fair bit of hard running."

Mainwaring played in a forward pocket and on a halfforward flank, and there were a few occasions when he was switched to centre-half-forward. "That's the way our forward line worked this year, and we were adapting to anything," he explained.

Mainwaring and Delacey share something else in common. Each has had the disappointment of playing in a losing colts grand final, Mainwaring in 2020 and Delacey the following year.

"I went through all the Claremont development squads, from under 12s upwards, mainly as a winger or midfielder," said Mainwaring. "In Year 12 at Scotch College I turned into a small forward and ended up winning the goalkicking list. I was lucky because our key forward was injured and missed quite a few games."

He has been on a steady learning curve in his time with the Tigers. "Coach Ash Prescott has been a great influence,



and forward coach Glen McCallum has been huge for me in the early stages of this year," said Mainwaring.

"We had a pretty hard-hitting conversation which went along the lines of 'you've got to drop a bit of arrogance and listen to what the coach has to say; get around your teammates a bit more and focus on the team game which will help you to become a better player.'

"So, I did listen to Glen, and I think that was a massive thing for me and helped me to improve. Alex manual is a mature head who is always so positive and willing to help with advice. I was able to always fall back on him, and he has been huge for me."

Delacey, who was a midfielder in his early days with the North Albany club, agreed with Mainwaring, saying: "I was having a lot of goalkicking struggles at the start of the year with my set shots, and Glen taught me a few things. Mainy and Ty (Smallwood) have also helped me with my goalkicking, while Alex always spoke to me and told me what to do during a game."

Mainwaring and Delacey agreed that they preferred kicking goals on the run, rather than taking set shots. Delacey's favourite major was the goal he kicked in the final seconds of the match which sealed Claremont's twopoint victory over Peel Thunder at Revo Fitness Stadium in round nine.

Mainwaring's favourite goal was also scored at home, from the right pocket at the railway end of the ground. "I got a little handball from Bailey Rogers, and I kicked a drop-punt which curled back in," he said.

Both players said they enjoyed taking high marks, with Mainwaring saying "It is definitely a cherry on top when you can take a nice a nice high mark as a smaller type of guy. It shows that you have got something over your opponent, not only on the ground but in the air as well."

Mainwaring has only just cast aside many pre-match superstitions, and his only ritual is enjoying his mother's spaghetti bolognaise on the night before every game, while Delacey dines on pasta on the night before a match followed by sushi on the morning of the game.

They have a message for club supporters, saying: "We're going to put in a massive pre-season, like we always do. We have a very committed group."

And Mainwaring urges: "Just stick with us; keep supporting us. We know what we've got to work on. Ash is working hard behind the scenes on a few things. We are all committed to going those few steps further. We are going to work hard, and hopefully we can bring the trophy home."

#### Note 1. Significant accounting policies

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

#### New or amended Accounting Standards and Interpretations adopted

Claremont Football Club Inc. has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period and effective for an accounting period that begins on or after 1 November 2022. Any new revised or amended accounting standards or interpretations that are not set mandatory have not been early adopted.

The adoption of these Accounting Standards and Interpretations did not have any significant impact to the financial performance or position of the Association.

#### **Basis of preparation**

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards - Simplified Disclosure Requirements and Interpretations issued by the Australian Accounting Standards Board ('AASB'), the Associations Incorporation Act 2015 (WA) and associated regulations, as appropriate for not-for-profit oriented entities.

#### Historical cost convention

The financial statements have been prepared under the historical cost convention.

#### Critical accounting estimates

The preparation of the financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying Claremont Football Club Inc.'s accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in note 2.

#### Note 1. Significant accounting policies (continued)

#### **Revenue recognition**

Revenue is recognised at an amount that reflects the consideration to which the association is expected to be entitled in exchange for transferring goods or services to a customer. For each contract with a customer, the association: identifies the contract with a customer; identifies the performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised.

Variable consideration with the transaction price, if any, reflects concessions provided to the customers such as discounts, rebates and refunds, any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the 'expected value' or 'most likely amount' method. The measurement of the variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that it is highly probably that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the uncertainty associated with the variable consideration is subsequently resolved. Amounts received that are subject to the constraining principle are recognised as a refund liability.

#### Sales revenue

Events, fundraising and raffles are recognised when received or receivable.

#### Donations

Donations are recognised at the time the pledge is made.

#### Grants

Grants are recognised at their fair value where there is a reasonable assurance that the grant will be received and all attached conditions will be complied with.

#### Interest

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial assets.

#### Other revenue

Other revenue is recognised when it is received or when the right to receive payment is established.

#### **Borrowing Costs**

Borrowing costs are recognised as an expense when incurred.

#### Leases

The determination of whether an arrangement is or contains a lease is based on the substance of the arrangement and requires an assessment of whether the fulfilment of the arrangement is dependent on the use of a specific asset or assets and the arrangement conveys a right to use the asset.

#### (i) Club as a lessee

Finance leases, which transfer to the club substantially all the risks and benefits incidental to ownership of the leased item, are recognised at the inception of the lease at the fair value of the leased property or, if lower, at the present value of the minimum lease payments. Lease payments are apportioned between the finance charges and reduction of the lease liability so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are recognised as an expense in profit or loss. Capitalised leased assets are depreciated over the shorter of the estimated useful life of the asset and the lease term if there is no reasonable certainty that the Club will obtain ownership by the end of the lease term.

#### Note 1. Significant accounting policies (continued)

#### Leases (continued)

Operating lease payments associated with short-term leases and leases of low-value assets are recognised on a straight- line basis as an expense in profit or loss. Short term leases are leases with a lease term of 12 months or less. Low-value assets comprise of office equipment.

#### Current and non-current classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in Claremont Football Club Inc.'s normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the Claremont Football Club Inc.'s normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

#### Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

#### Trade and other receivables

Other receivables are recognised at amortised cost, less any provision for impairment.

#### Inventories

Inventories are measured at the lower of cost and net realisable value. Inventories are accounted for at purchase cost on a first in first out basis.

#### Investments and other financial assets

Investments and Financial assets in the scope of AASB 139 *Financial Instruments: Recognition and Measurement* are classified as either financial assets at fair value through profit or loss, available for sale investments or loans and receivables. When financial assets are recognised initially, they are measured at fair value. The Club determines the classification of its financial assets at initial recognition.

#### (i) Classification of financial instruments

- The Association classifies its financial assets into the following measurement categories:
- those to be measured at fair value (either through other comprehensive income, or through profit or loss); and
- those to be measured at amortised cost.

The classification depends on the Association's business model for managing financial assets and the contractual terms of the financial assets' cash flows.

The Association classifies its financial liabilities at amortised cost unless it has designated liabilities at fair value through profit or loss or is required to measure liabilities at fair value through profit or loss such as derivative liabilities.

#### (ii) Financial assets measured at amortised cost

#### Debt instruments

Investments in debt instruments are measured at amortised cost where they have:

- contractual terms that give rise to cash flows on specified dates, that represent solely payments of
  principal and interest on the principal amount outstanding; and
- are held within a business model whose objective is achieved by holding to collect contractual cash flows.

#### Note 1. Significant accounting policies (continued)

#### Investments and other financial assets (continued)

These debt instruments are initially recognised at fair value plus directly attributable transactions costs and subsequently measured at amortised cost. The measurement of credit impairment is based on the three-stage expected credit loss model described below in note (c) Impairment of financial assets.

(a) Financial assets measured at fair value through other comprehensive income

#### Equity instruments

Investment in equity instruments that are neither held for trading nor contingent consideration recognised by the Association in a business combination to which AASB 3 "Business Combination" applies, are measured at fair value through other comprehensive income, where an irrevocable election has been made by management.

Amounts presented in other comprehensive income are not subsequently transferred to profit or loss. Dividends on such investments are recognised in profit or loss unless the dividend clearly represents a recovery of part of the cost of the investment.

#### (b) Items at fair value through profit or loss

Items at fair value through profit or loss comprise:

- \* items held for trading;
- \* items specifically designated as fiar value through profit or loss on initial recognition; and
- \* debt instruments with contractual terms that do not represent solely payments of principal and interest.

Financial instruments held at fair value through profit or loss are initially recognised at fair value, with transaction costs recognised in the income statement as incurred. Subsequently, they are measured at fair value and any gains or losses are recognised in the income statement as they arise.

Where a financial asset is measured at fair value, a credit valuation adjustment is included to reflect the credit worthiness of the counterparty, representing the movement in fair value attributable to changes in credit risk.

#### Financial instruments held for trading

A financial instrument is classified as held for trading if it is acquired or incurred principally for the purpose of selling or repurchasing in the near term, or forms part of a portfolio of financial instruments that are managed together and for which there is evidence of short-term profit making, or it is a derivative not in a qualifying hedge relationship.

#### Financial instruments designated as measured at fair value through profit or loss

Upon initial recognition, financial instruments may be designated as measured at fair value through profit or loss. A financial asset may only be designated at fair value through profit and loss if doing so eliminates or significantly reduces measurement or recognition inconsistencies (i.e. eliminates an accounting mismatch) that would otherwise arise from measuring financial assets or liabilities on a different basis.

A financial liability may be designated at fair value through profit or loss if it eliminates or significantly reduces an accounting mismatch or:

\* if a host contract contains one or more embedded derivatives; or

if financial assets and liabilities are both managed and their performance evaluated on a fair value basis in accordance with a documented risk management or investment strategy.

Where a financial liability is designated at fair value through profit or loss, the movement in fair value attributable to changes in the Association's own credit quality is calculated by determining the changes in credit spreads above the observable market interest rates and is presented separately in other comprehensive income.

#### (c) Impairment of financial assets

The Association applies a three-stage approach to measuring expected credit losses (ECLs) for the following categories of financial assets that are not measured at fair value through profit or loss:

\* debt instruments measured at amortised cost and fair value through other comprehensive income;

- \* loan commitments; and
- \* financial guarantee contracts.

#### Notes to the financial statements For the year ended 31 October 2023

#### Note 1. Significant accounting policies (continued)

#### Investments and other financial assets (continued)

No ECL is recognised on equity investments.

#### Determining the stage for impairment

At each reporting date, the Association assesses whether there has been a significant increase in credit risk for exposures since initial recognition by comparing the risk of default occurring over the remaining expected life from the reporting date and the date of initial recognition. The Association considers reasonable and supportable information that is relevant and available without undue cost or effort for this purpose. This includes quantitative and qualitative information and also, forward- looking analysis.

An exposure will migrate through the ECL stages as asset quality deteriorates. If, in a subsequent period, asset quality improves and also reverses any previously assessed significant increase in credit risk since origination, then the provision for doubtful debts reverts from lifetime ECL to 12-months ECL. Exposures that have not deteriorated significantly since origination are considered to have a low credit risk. The provision for doubtful debts for these financial assets is based on a 12-months ECL. When an asset is uncollectible, it is written off against the related provision. Such assets are written off after all the necessary procedures have been completed and the amount of the loss has been determined. Subsequent recoveries of amounts previously written off reduce the amount of the expense in the income statement.

The Association assesses whether the credit risk on an exposure has increased significantly on an individual or collective basis. For the purposes of a collective evaluation of impairment, financial instruments are grouped on the basis of shared credit risk characteristics, taking into account instrument type, credit risk ratings, date of initial recognition, remaining term to maturity, industry, geographical location of the borrower and other relevant factors.

#### (d) Recognition and derecognition of financial instruments

A financial asset or financial liability is recognised in the balance sheet when the Association becomes a party to the contractual provisions of the instrument, which is generally on trade date. Loans and receivables are recognised when cash is advanced (or settled) to the borrowers.

Financial assets at fair value through profit or loss are recognised initially at fair value. All other financial assets are recognised initially at fair value plus directly attributable transaction costs.

The Association derecognises a financial asset when the contractual cash flows from the asset expire or it transfers its rights to receive contractual cash flows from the financial asset in a transaction in which substantially all the risks and rewards of ownership are transferred. Any interest in transferred financial assets that is created or retained by the Association is recognised as a separate asset or liability.

A financial liability is derecognised from the balance sheet when the Association has discharged its obligation or the contract is cancelled or expires.

#### (e) Offsetting

Financial assets and liabilities are offset and the net amount is presented in the balance sheet when the Association has a legal right to offset the amounts and intends to settle on a net basis or to realise the asset and settle the liability simultaneously.

#### Property, plant and equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Depreciation is calculated on a straight-line basis to write off the net cost of each item of property, plant and equipment (excluding land) over their expected useful lives as follows:

Buildings	40 years
Leasehold improvements	15 years
Plant and equipment	3-7 years
Motor vehicles	5-7 years
Office equipment	3-5 years

#### Note 1. Significant accounting policies (continued)

#### Property, plant and equipment (continued)

The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date.

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the Claremont Football Club Inc. Gains and losses between the carrying amount and the disposal proceeds are taken to profit or loss.

#### Impairment of non-financial assets

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

#### Interest-bearing loans and borrowings

All loans and borrowings are initially recognised at the fair value of the consideration received less and directly attributable transaction costs.

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost using the effective interest method.

Gains and losses are recognised in profit or loss when the liabilities are derecognised.

#### Trade and other payables

These amounts represent liabilities for goods and services provided to the Claremont Football Club Inc. prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

#### **Employee benefits**

#### Short-term employee benefits

Liabilities for wages and salaries, including non-monetary benefits, annual leave and long service leave expected to be settled wholly within 12 months of the reporting date are measured at the amounts expected to be paid when the liabilities are settled.

#### Other long-term employee benefits

The liability for annual leave and long service leave not expected to be settled within 12 months of the reporting date are measured at the present value of expected future payments to be made in respect of services provided by employees up to the reporting date using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures and periods of service. Expected future payments are discounted using market yields at the reporting date on national government bonds with terms to maturity and currency that match, as closely as possible, the estimated future cash outflows.

#### Defined contribution superannuation expense

Contributions to defined contribution superannuation plans are expensed in the period in which they are incurred.

#### Note 1. Significant accounting policies (continued)

#### Fair value measurement

When an asset or liability, financial or non-financial, is measured at fair value for recognition or disclosure purposes, the fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date; and assumes that the transaction will take place either: in the principal market; or in the absence of a principal market, in the most advantageous market.

Fair value is measured using the assumptions that market participants would use when pricing the asset or liability, assuming they act in their economic best interests. For non-financial assets, the fair value measurement is based on its highest and best use. Valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, are used, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

#### Goods and Services Tax ('GST') and other similar taxes

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the tax authority is included in other receivables or other payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the tax authority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

#### **Comparative Figures**

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current year.

#### **Going Concern**

The financial statements have been prepared on a going concern basis which contemplates the continuity of normal business activities and the realisation of assets and the settlement of liabilities in the ordinary course of business.

For the year ended 31 October 2023, the Club generated a Net Surplus of \$164,896 (2022: \$155,833) and had cash inflows from operating activities of \$263,587 (2022: \$222,022).

The Club has overdraft facilities of \$400,000 which was undrawn at the balance date.

The Board has prepared a budget, which indicates that the Club will have sufficient cash flows to meet all commitments and working capital requirements for the 12 month period from the date of signing this financial report. On this basis the Board is satisfied that the going concern basis of preparation is appropriate.

#### Note 2. Critical accounting judgments, estimates and assumptions

The preparation of the financial statements requires management to make judgments, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgments and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgments, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgments and estimates will seldom equal the related actual results. The judgments, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

#### Estimation of useful lives of assets

Claremont Football Club Inc. determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

Impairment of non-financial assets other than goodwill and other indefinite life intangible assets Claremont Football Club Inc. assesses impairment of non-financial assets other than goodwill and other indefinite life intangible assets at each reporting date by evaluating conditions specific to Claremont Football Club Inc. and to the particular asset that may lead to impairment. If an impairment trigger exists, the recoverable amount of the asset is determined. This involves fair value less costs of disposal or value-in-use calculations, which incorporate a number of key estimates and assumptions.

#### Employee benefits provision

As discussed in note 1, the liability for employee benefits expected to be settled more than 12 months from the reporting date are recognised and measured at the present value of the estimated future cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, estimates of attrition rates and pay increases through promotion and inflation have been taken into account.

#### **Redevelopment Activities**

In 2017, the Club completed redevelopment activities at Claremont Oval pursuant to an agreement with LandCorp whereby the parties agreed to the cancellation of the Club's lease, and granted freehold title of the Clubhouse land to the Club on a conditional use basis. Redevelopment Activities were funded by Landcorp, up to an amount of \$16.5m, and have not been reflected in this financial report.

As part of the redevelopment, and pursuant to an agreement between the Club, the Town of Claremont and the purchaser of the land immediately to the north of the Club's facilities, the Club was entitled to 81 car bays. In 2021, the construction of the 81 car bays in the basement of the building to the north of the Club's facilities was completed. The Club made a contribution (funded by Landcorp) of \$1m to the cost of their construction. The value of these car bays has not been reflected in this financial report.

#### Maintenance Fund

During 2018, the excess land to the North of the Club facilities was sold by the Government and \$1.5m of the proceeds was granted to the Club pursuant to the terms of a Trust Deed.

Under the terms of the Trust Deed, the Club is required to keep these proceeds, and any interest earned, in an auditable Trust Account. The funds held in the Trust Account (separate to the financial statements) may only be applied to the costs of repairing, maintaining, and renewing the Club's premises in accordance with an Asset Management Plan that has been approved by the Government.

During the year, \$91,158 was expended by the Club on such repairs and maintenance. Of this amount, no funds were sourced from the Trust Account, with the entirety of such repairs and maintenance being funded by operating cashflows. At year end, the closing balance of the Trust Account was \$1,540,379.
