**W**ith the Covid Pandemic melting away in the background the Swansmen were able to enjoy a very busy and **VERY** successful 2022 and once again provide many opportunities for our members to enjoy good fellowship and help raise some very valuable money for the Club at the same time.

It was an exciting year on field, with the Men's Reserves and the Women's League and Reserves sides reaching the finals. Unfortunately, neither side made it to the Grand Final but it was a great effort none the less. The Men's League team was unlucky not to make Finals bowing out in the last game of the season. The addition of an Integrated team into the Perth Football League All Abilities Competition was a great success with the team making Finals in their first year, another great effort by all concerned. We congratulate the whole football department and the Men's, Women's and Integrated teams on their outstanding seasons and the continuing effort to develop home grown players for the future. The Swansmen appreciate the support received from Phil Smart and the coaching staff, both male and female, and to the players for making themselves available to speak at our dinner meetings. We look forward to the 2023 season.

The year commenced as normal with the Annual Planning Seminar in February followed by the Lounge Busy Bee. The first of the Swansmen monthly dinners kicked off in March as did the fundraising for 2022.

The monthly dinner meetings were successful with approximately 30 in attendance each month. We heard from coaches, players and a diverse range of entertaining guest speakers. They are all featured on later pages.

- Swansmen Lounge Home Game Bar \$5,200 (thanks to 'bar manager' Peter Bacon).
- Plus, our Membership subs, Club 20, Sponsor-A-Picket, monthly dinner meetings and fines.

This amount was returned to the Club through the annual sponsorship of a Count-Me-In table; renovations towards the office of the Women's League Coach; the Women's League Best Player Awards; the Men's League Leading Goal Kicking Award and an end of season cash donation to the Club of \$97,000 (including the Auction and Wine Wall).

The support of the Thursday Members' night has been outstanding on all fronts. I would like to sincerely thank your committee for their support and strong contribution this year and to all the Club staff for their assistance and catering. I also acknowledge the interaction and cooperation we have with the Board, Club Staff and the Past Players & Officials Association.


We welcome new members to the Swansmen group. It is a great way to support the Club and get to experience it from the inside. Good luck to everyone for season 2023.

#### March Adam Pickering (SDFC League Coach)

#### **NOTES TO THE FINANCIAL STATEMENTS**

#### **Note 1: Statement of Significant Accounting Policies**

**T**his financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements under the Associations Incorporation Act 2015 (WA). To comply with the new Act, a revised Constitution was lodged with the Department of Mines, Industry Regulation & Safety in June 2019.

The Committee has determined that the Association is not a reporting entity because there are no users dependent on general purpose financial statements. Under the Act, the Association is classified as Tier 1 for reporting purposes and does not require an annual review or audit unless requested.

#### **Note 2: Current Liability**

The Swansmen are committed to pay out the Chase the Ace Jackpot at some time in the future.

#### Scope

I have reviewed the attached Special Purpose Financial Statements of the Swansmen Incorporated which comprises the Statement of Financial Position, Detailed Profit and Loss Statement, Summary of Key Activities, Notes to the Financial Statement and the Statement by Members of the Committee for the year ended 31<sup>st</sup> October 2022

#### Committee Responsibility

The Committee and its members are responsible for the preparation and presentation of the Financial Report and the information contained therein, and has determined the basis of reporting below. I have conducted an independent review of the Financial Report in order to express an opinion as requested by the Committee. Accordingly, I do not express an audit opinion. The review evidence I have obtained is sufficient and appropriate to provide a basis for the conclusion listed below.

Whilst I am a life member of the Swansmen Incorporated I consider that I am independent of the Committee and its Members and therefore sufficiently "independent" as required by the Act.
