PFL matches are the intellectual property of the PFL. PFL wish to protect the PFL's imagery, sponsors and reputation where filming and live streaming of PFL matches occur.

Some media production companies offset their costs with their own broadcast sponsors and advertisers promoted throughout live streams which may conflict with PFL sponsors.

Where media production companies are engaged by clubs, the media production company should be aware of PFL's obligations relating to copyright permission to film and/or stream PFL matches and sponsorship/advertising conflicts.

We also wish to ensure host venues are aware of any filming arrangements for venue accessibility, camera and tent locations, electricity, etc, so Grand Finals run smoothly.

PFL FILMING OBLIGATIONS

- 1. To not broadcast sponsors and advertisers which conflict with PFL sponsors and advertisers.
- 2. To provide access to streaming links so the PFL can promote respective Grand Finals through its social media channels.
- 3. To provide Grand Final footage (or links) that may be upload to the PFL's virtual history website and be used for future promotional use by the PFL.
