Proposed amendments to Player Point System	Clubs are invited to provide feedback by COB
By-law with regards to Total Team Points	Wednesday 24 th November 2021.
reduction and change to Season of Service definition are distributed for feedback from clubs.	

Background

- Season 2021 was the fourth year of the PPS. Implementation of the PPS has been considered a five-year plan.
- With clubs actively recruiting players for 2022, any amendment to the Total Team Points cap needs to be advised as earliest as possible.
- Staff have reviewed the PPS Schedule within the By-laws, and recommend the following be presented to clubs for feedback.

This agenda item addresses two key areas:


- 1. Reducing the Total Team Points cap for the PPS to remain effective.
- 2. Amending the definition of Seasons of Service to address an anomaly between three year look back and Season of Service.

Total Team Points Reduction

In December 2020, the Board approved a road map to reduce Total Team Points from 43 to 40 points for season 2022. This road map was communicated to clubs via the Club President Facebook Page, 9th December 2020.

The below table supports the Board reducing the Total Team Points cap from 43 points to 40 points per team per match for season 2022.

Average Total Team Points Per Grade



Recommendation: That Total Team Points reduce from 43 to 40 points.

Seasons of Service

In 2021, six clubs (West Coast, Scarborough, North Beach, Trinity Aquinas, Kingsway and Cottesloe) expressed concerns on assessments made to nine players. Club examples were consistent with an anomaly between three year look back and Season of Service. Players have been at their respective clubs since 2018 and could have transferred to another Perth Football League club in season 2021 on less points.

Examples provided:

Player scenario 1:

- 2017 played 9 WAFL League games.
- 2018 played 9 PFL games.
- 2019 & 2020 due to work commitments, personal issues and Covid did not play.
- 2021 played 9 PFL games (5 points). Another PFL Club he would be 3 points.
- 2022 player is eligible for 1 point reduction. (now 4 points).
- For season 2022 player can still transfer to another Perth Football League club and be worth 3 points.

Player scenario 2:

- 2016 played 19 WAFL League games
- 2017 played 17 WACFL games
- 2018 player played 19 PFL games (4 points)
- 2019 played 1 PFL game, suffered season ending injury.
- 2020 played 8 PFL games. (Increased to 5 points due to reclassification of WAFL League players in 2019. Another PFL Club he would be 3 points.
- 2021 played 15 PFL games. (4 points). Another PFL Club he would be 3 points.
- 2022 player is eligible or 1 point reduction.

All the other concerns were of the similar nature and related to players not meeting the 5-game minimum requirement to earn a point deduction due to injury, health/personal issues, and work commitments. Also, all had not played WAFL for over 4 years.

This amendment will mean that players can reduce their player point category quicker and will be subsequently reflected in Total Team Point reductions overtime.

Recommendations:

- a) That a Season of Service commence after the first season.
- b) That a player is only required to be registered at his respective club (i.e not required to play) for a Season of Service to be recognised.

Suggested By-law amendment

4. SEASONS OF SERVICE

- a) Whilst remaining at his Perth Football League club, a player shall reduce his points value by 1 point for each season he is registered at his respective Perth Football League club.
- b) A player may commence reducing his points value after his first season.

For the avoidance of doubt, if the player transfers to another club, the player will be subject to the highest level of football in accordance with the Player Points Categories.
