IMPLEMENTATION PROGRAM

The WAFC Strategic Facilities Plan is an aspirational 10-year plan designed to be practical and realistic in its implementation, with key actions to be delivered between 2020 to 2030. Stakeholder wide commitment to implementation, communication, cooperation, involvement and ownership of recommended priority areas and supporting actions will be essential to the future sustainability and growth of football.

SUMMARY

KEY:

Following the launch of the WAFC's Strategic Facilities Plan (2020-2030) in mid-2020, positive steps were taken in 2021 in terms of completing Female Facilities and Lighting projects. 12 lighting projects were completed (target of 11) and 16 Female amenities upgrades were completed (target of 14) which was a great result in the first full year of the Facilities plan being delivered upon.

The WA Facilities team provided support to 42 projects, managed by Local Government and football clubs in 2021. 15 projects received funding via the AFL Facilities Fund and WAFC Facilities support budget. In total, the AFL Facilities Fund committed \$1.2M to support WAFC Facility projects in 2021.

The Strategic Facilities Plan has a very strong focus on enhancing community facilities, though also has AFL Tier 2 status as an objective. Leederville and Fremantle Ovals were identified by the WAFC and AFL as the preferred venues to host televised evening AFLW and AFL Mens Pre-season fixtures, requiring a minimum of 1000 lux lighting. Leederville Oval is currently part of the WA Government's Community Sports & Recreation Facilities Fund (CSRFF) process, with the City of Vincent very supportive of the overall goal for the venue. Fremantle Community Bank Oval is undergoing a detailed business case for a broader facility redevelopment, and 1000 lux lighting forms part of those discussions between the WAFC, South Fremantle Football Club and the City of Fremantle.

Of the other WAFL facilities, East Fremantle Football Club move temporarily to the WACA ground for 2022 as their headquarters undergoes an approximate \$35m redevelopment. Likewise, Perth Football Cub's home at Lathlain Park has approval for a \$15m redevelopment of their facility which will incorporate space for community usage. All other WAFL venues have plans in place to develop their facilities; Claremont (lighting), Swan Districts (Large scale redevelopment and lighting), West Perth (Lighting) and Peel Thunder (Additional facilities and enhanced lighting).

Regionally, plans for a \$15m redevelopment at Hands Oval in Bunbury continue to progress and this will make the venue a high quality hub for football in the South West region. Other important projects will be undertaken in the South West Football and Goldfields Football Leagues, with changeroom shower retrofitting making both of these leagues inclusive for all participants. Discussions have also commenced with the Shire of Broome over a new sports facility at the Broome Recreation & Aquatic Centre, with a focus on building a Leadership and Learning Centre within the overall precinct.

Announced in late September, the AFL and WA State Government committed a combined \$5,000,000 across five (5) years towards delivery of the Kimberley Football Strategy. Infrastructure is an important component of the strategy as illustrated by the following facility objectives;

- 1. Develop a five year capital expenditure plan to consider key locations, community need, gaps and funding partners
- 2. Identify specific projects to upgrade and improve lighting in all Kimberley regional centres and remote communities
- 3. Establish a Centre of Excellence in Broome to support the development of players, umpires, coaches and administrators

OBJECTIVES FOR 2022

- As per the 2022 Operational Plan's performance measures, an increase to the WA Football Facilities Fund from \$100,000 per annum to a minimum
 of \$1,000,000 has been approved. This amount will be matched by the AFL and will be administered via a set of application guidelines. Details of the
 fund and its application will be distributed to the WA football industry. Previously, WAFC has been able to offer nominal contributions to such things
 as Business Cases and Feasibility studies, so this fund will allow WAFC to support projects that are 'stuck' due to local government and club funding
 shortfalls.
- To have completed a Feasibility Study and Business Case on the proposed WAFC Future Home, including principle support from the State Government. At present, the WAFC has seven (7) years remaining on our lease at Tuart College and, whilst this is currently providing a very suitable home for WA Football, the intention is to return to Subiaco Oval provided it is feasible to do so.
- 12 lighting projects and 16 female retrofitting (amenities) projects are the targets for 2022
